MINUTES OF THE PREVIOUS ANNUAL GENERAL MEETING:

It was agreed that the minutes of the meeting held on 15th June 2023 be taken as read. There were no matters arising.

OFFICERS' REPORTS:

Secretary (Ian George)

The secretary noted the introduction of a scheme, with the support of the Cornwall Chess Trust, to provide financial support for travel to away matches.

The family of our late president. Professor David Jenkins had made an extremely generous donation towards a trophy in his name. A cup, named the "David Jenkins Cup", had been purchased to be presented annually to the winner of the Cornwall Rapid Play Championship. A further cup for the new Minor League was also purchased, leaving £290 unspent. It was agreed that a fund, to be called the "David Jenkins Memorial Fund" should be created with this money and put towards the rapid play tournaments organised by the association.

Treasurer (lan George)

The Treasurer presented the accounts for the period from 2023/24 season and reported that the state of the Association's finances was satisfactory. Total funds amounted to £2,354, including £768 in the Napier Fund for junior chess. The bank balance at 11/6/23 was £1,432. Grants approved by the trust but not yet paid amounted to £1,173 (Falmouth congress £449, club travel expenses £724). With trust support, all congresses have broken even.

The accounts were approved and are appended to these minutes.

The treasurer's recommendation that no fees should be charged to affiliated clubs for the 2024/25 season was approved.

League Secretary (Hugh Brown)

The County Shield and the new Minor League were won by Bude. The A. W. Busby Cup and Quickplay League were both won by Camborne.

CORNWALL CHESS TRUST

The trust secretary, Ian George, reported that to date the trust had paid grants of £7,241, with a further £1,549 approved and awaiting payment. These grants included support for the Falmouth and Penzance congresses, assistance to clubs, including a giant outside board and set, and 5 digital clocks for the Newquay club.

The trustees were anxious to support junior chess and clubs and would consider all applications in respect of viable projects contributing to the development of chess in Cornwall.

County Shield

A. W. Busby Cup

5 entries were noted from Bude, Camborne, Falmouth & Truro, Newquay, North Cornwall.

It was agreed that the format should be a knock -out competition with a preliminary match to eliminate one team. The league secretary to make the draw early in July.

Quick Play League

7 entries were noted. East: Bude (possibly 2), Calstock, Liskeard. West: Camborne (2), Falmouth & Truro, Newquay.

It was agreed that the format should be two double-round all-play-alls: followed by a final match between the winners of the East and West sections.

Minor League

4 entries were noted from Bude, Camborne, Falmouth & Truro, Lerryn, Newquay.

It was agreed that the format should be a double all-play-all league.

- "Teams will consist of four players. The average rating of the players in a team may not exceed 1450. Where a team is unable to field four players, any absent players whose boards are defaulted, will be assumed to be rated 1200."
- b) That rule 7(a) of the Quickplay League rules be amended to read as follows:
- "Teams will consist of four players, arranged in order of current player ratings. Where a team is unable to field four players, any absent players whose boards are defaulted, will be assumed to be rated 1400."

The proposal was approved

PROPOSAL: (Lloyd Retallick. Seconder: Ian George)

That rule 4) of the Rules Applicable to All Team Matches be amended to read as follows:

- "a) Subject to 4(b), teams will be arranged in order of current player ratings as published by the ECF.
- b) Notwithstanding 4(a), players whose ratings differ by less than 100 points may be placed in relation to each other in the order decided upon by the team captain."

The ratings to be used shall be those published in rating list published by the ECF on the 1st July prior to the start of the season.
